**INFORMATION ON THE PROCESSING OF PERSONAL DATA**  
**INFORMATION IN ACCORDANCE WITH EU REGULATION 2016/679 (CDGDPR GENERAL DATA PROTECTION REGULATION)**

Pursuant to Article 13 of EU Reg. 2016/679 Vika Srl provides the necessary information regarding the processing of personal data and communicates the following.

**art. 1 – Data controller.**

The data controller of your personal data is Vika Srl (P. IVA 11780070014), with registered office in Turin, C.so Germano Sommeiller n. 31.

**art. 2 – Purpose of the processing.**

VESI data provided may be collected for one or more of the following purposes:

- Allow the owner to provide their services;
- fulfill contractual and pre-contractual obligations established or to be established with customers;

**art. 4 – Duration of treatment.**
